



**Lithium (LiFePo4) Batteries  
8 YEAR LIMITED WARRANTY  
(Effective May 1, 2024)**

ECO Capital, Inc. (the Manufacture, hereafter "ECO Capital") warrants each Eco Battery branded Lithium Iron Phosphate (LiFePO4) battery (each, a "Battery") sold by ECO Capital or any of its authorized distributors or dealers, to be free of manufacturers defects for a period of 8 years (the "Warranty Period") from the date of sale as determined by buyer's sales receipt.

**NON-TRANSFERABLE**

This Limited Warranty is to the original purchaser of the Battery and is not transferable to any other person or entity. Please contact the place of purchase regarding any warranty claim.

**WARRANTY EXCLUSIONS**

This Limited Warranty does not cover any Battery subjected to the following conditions:

- Damage due to being unsecured or insufficiently secured
- Improper installation, use, maintenance, or service
- Loose Battery terminal connections
- Batteries connected in series
- More than 3 Batteries connected in parallel
- Reverse polarity connections
- Inappropriate storage conditions as defined by the Owner's Manual for such Battery, including but not limited to, exposure to extreme ambient temperatures above 140F or below -40F, fire, any type of water submersion and or pressure washing, and/or storing the Battery in a completely discharged state
- Any short circuit caused by accidental, intentional, or inadvertent connection of the positive and negative terminals
- Damage caused by impact, accident, collision, or drop
- Under/over charging the Battery as defined in its respective Battery Owner's Manual
- Use with other third-party product(s) which fail
- High resistance as a result of corroded terminals, poor crimps, or insufficient cable size
- Battery that fails as a result of a faulty electrical system
- Battery that has been opened, modified or tampered with in any way. • Battery that was used for applications other than which it was designed and intended for, including repeated engine starting, or drawing more amps than the Battery is rated to continually discharge in its respective specifications
- Battery that has not been charged for over 1 year (Batteries need to be charged periodically to maintain Battery cell health)
- Battery that has been used in a commercial application where it is cycled to more than 80% depth of discharge repeatedly within 24 hour periods.

**Batteries purchased from non-authorized dealers carry no warranty.**

The warranty does not cover failures that occur outside the United States. Service calls, towing, loss of time, inconvenience, and loss of use of the vehicle, lost wages, lost profits, or any other consequential or incidental damages are hereby specifically excluded from this Warranty.

**PRORATED BASIS, REGISTRATION REQUIRED FOR FULL TERM COVERAGE**

Buyer must register buyer's Battery at [ecobattery.com/s/warranty-registration](http://ecobattery.com/s/warranty-registration) in order to receive full warranty coverage. Any Battery not registered within 60 days from date of purchase shall be covered by the conditions of this warranty policy for a period of one (1) year from date of purchase shown on proof of purchase.

All registered Batteries shall be covered by a free credit, replacement or repair for a period of thirty six (36) months from date of purchase. After the thirty six (36) months, all registered Batteries shall be covered on a prorated basis beginning from the date of purchase.

Within the first thirty six (36) months of the Warranty Period, subject to the exclusions listed above, if the Battery is determined to be defective in material or workmanship, ECO Capital will, at its own discretion, credit, replace or repair the Battery and/or parts of the Battery. After thirty six (36) months, if the Battery is determined to be defective in material or workmanship, ECO Capital will, at its own discretion, repair or replace the Battery on a prorated basis, as further described, starting from date of purchase. After thirty six (36) months, the warranty shall be prorated using the following formula: (original purchase price x (months since original purchase / 96) = buyer's payment for repair or replacement. The following table will serve as an example of the application of the formula above and will help the buyer understand its financial responsibility for repairs or replacement of a Battery after the initial three year period:

Buyer shall pay to ECO Capital the corresponding amount for which they are responsible, as provided using the formula above, for any requested repair or replacement after the first thirty six (36) months of the Warranty Period.

To reduce turnaround time and ensure the best customer experience, at times ECO Capital may elect to replace Batteries with a Certified Refurbished Battery of the same Battery type which is in as similar condition as possible. Conditions considered include cosmetic state, number of cycles and age. If a Battery is replaced with a Certified Refurbished Battery, the original purchase date specified upon filling out a registration form will transfer to the Certified Refurbished Battery. So long as a warranty is not voided, ECO Capital will honor the original purchase date of the Battery for the entire length of the 8-Year Limited Warranty, regardless of the number of replacements that occur.

## **Return Shipping**

In the event buyer's Battery needs to be returned to ECO Capital for any reason, it must be shipped in a lithium ion UN approved shipping box. If buyer did not save the original packaging, ECO Capital will need to send buyer packaging to return the Battery. The cost of this service for Batteries weighing up to 79 lbs will be \$25 plus the actual shipping charges to the destination. For Batteries weighing more than 79 lbs, buyer will need to contact ECO Capital for a box and shipping quote.

The cost of shipping and packaging to send the Battery to ECO Capital for warranty evaluation shall be the sole responsibility of the buyer. Any Battery deemed defective in material or workmanship shall be repaired or replaced, and returned to the buyer at the expense of ECO Capital.

ECO Capital recommends buyer fully insure any return shipment in case of loss or damage in transit. Buyer shall use a carrier that can provide buyer with tracking numbers and proof of delivery. If buyer needs assistance with shipping a Battery to ECO Capital for warranty evaluation, ECO Capital may require a deposit of \$300 to cover the cost of return shipping and diagnosis. Any shipment which arrives damaged or without an RMA will be refused or held at the warehouse until the buyer pays for return shipping or files an insurance claim.

## **WARRANTY DISCLAIMER**

This limited warranty is in lieu of, and manufacturer disclaims and excludes, all other express warranties. Manufacturer further limits the duration of all, whether statutory, express or implied warranties, including, without limitation, any warranty of merchantability or fitness for a particular purpose, to the warranty period. Manufacturer's exclusive liability for breach of any warranty on the Battery shall be to replace the Battery within the warranty period in accordance with the terms of this limited warranty. In no event shall Manufacturer be liable for any loss or damages of any other kind, whether direct, incidental, consequential including lost profits, exemplary, special or otherwise, including any lost profits or removal, shipping, property damage, injury, or installation expenses.

EXCEPT FOR THE WARRANTY SET FORTH ABOVE, SELLER MAKES NO WARRANTY WHATSOEVER WITH RESPECT TO THE GOODS, INCLUDING ANY (A) WARRANTY OF MERCHANTABILITY; OR (B) WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE; WHETHER EXPRESS OR IMPLIED BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE OR OTHERWISE.

## **LEGAL RIGHTS**

Some countries and/or states do not allow limitation on how long an implied warranty lasts or the exclusion or limitation of incidental or consequential damages, so the above limitations may not apply to buyer. This warranty gives you, as the buyer, specific legal rights, which may vary from country to country and/or state to state. This warranty shall be governed by and interpreted in accordance with the laws of Utah. This warranty is understood to be the exclusive agreement between the parties relating to the subject matter hereof. No employee or representative of ECO Capital is authorized to make any warranty in addition to those made in this agreement.

## **NON-WARRANTY REPAIRS**

If outside of the warranty period or for damage not covered under the warranty, ECO Capital, at its sole discretion, may offer to repair the Battery for a fee. ECO Capital will provide an estimate to repair and ship the Battery.

## **SUBMITTING A WARRANTY CLAIM**

To submit a warranty claim, please contact the original place of purchase, (Elite Service 2021 Limited) or visit [ecobattery.com/s/warranty-claim](http://ecobattery.com/s/warranty-claim). The Battery may be required to be shipped back to ECO Capital for further inspection.

An RMA (Return Merchandise Authorization) must be obtained from ECO Capital before any Battery may be returned. Any Battery that arrives without an RMA will be refused and any and all shipping charges will be the sole responsibility of the buyer. The RMA must be clearly marked on the outside of the shipment, or it will be refused.
